## Protection and Indemnity

The Swedish Club is a member of the International Group of P&I Clubs and offers full mutual P&I cover on a Group basis.

The Club's strategy is to provide long-term stability in pricing which will enable shipowners to budget future costs for P&I cover. We offer P&I insurance to owners as well as charterers and offer our members a wide range of additional and customised cover to complement their basic P&I insurance.

## Freight Demurrage and Defence

The Swedish Club has offered FD&D cover since 1984 and it is usually provided in conjunction with P&I insurance.

A member covered for FD&D has direct access to the Club's FD&D lawyers for advice and assistance even if no dispute has arisen. If in the case of dispute, external lawyers need to be instructed, our philosophy is to appoint individuals rather than firms, in order to obtain the particular expertise required, and we will manage the case for you.

## Energy and Offshore

From our office in Oslo, Norway, the Club writes a wide range of insurance cover including H&M, Interest and Loss of Hire for Mobile Offshore Units and FPSOs.

Team Norway also handles the Club's marine insurance activities for Norwegian and international Offshore Service Vessels, with risks written on recognised international hull conditions.

## Kidnap and Ransom

The Swedish Club's Kidnap & Ransom insurance protects your organisation against the financial loss that can arise when a crew and/or vessel is seized or detained for ransom. We also provide access to Kidnap & Ransom experts and other consultants who will assist to resolve the incident successfully.

## Increased Value Insurance and Freight Interest Insurance

This product covers against total loss of the insured vessel and is an extension of the H&M cover, activated only if the vessel is a total loss or a constructive total loss.

## Hull and Machinery

Good relationships and close cooperation with our members are the hallmarks of our H&M claims handling process. We can offer on-site assistance from our in-house surveyor and/or technical experts, while claims are generally adjusted by our team of in-house adjusters, offering time and cost benefits both to you and the Club.

## War Risks

War perils are typically excluded under standard H&M conditions. The Swedish Club offers owners and charterers comprehensive worldwide war risk cover based on the war conditions associated with the entry for H&M conditions.

## Loss of Hire

The Swedish Club's Loss of Hire insurance will protect against an unexpected shortfall in earnings due to physical damage to a vessel, which can prove useful to an owner operating on tight margins.
